

## Preface

The Society of Statistics, Computer and Applications (SSCA) was founded in 1998 with a goal to provide a platform for promotion and dissemination of research in Statistics, blended with information technology, among both the theoretical and applied statisticians, who have keen interest in the applications of Statistics in varied fields like agriculture, biological sciences, medical sciences, finance statistics, industrial statistics, etc. Since then the Society has been performing several activities and promoting and popularizing development of theoretical and applied research work in statistics and informatics.

Organizing national conferences every year is one of the major activities of the SSCA. The society has organized twenty-one conferences thus far.
